

J3dv JavaScript Library License Agreement

This License Agreement is a legal agreement between You and Licensors for the Software provided with this Agreement. By installing, copying, or otherwise using the Software, You agree to be bound by the terms of this license agreement. If You do not agree to the terms of this license agreement, do not install or use the Software. Licensors reserves the right to modify this Agreement at any time without giving You prior notice.

The Software includes components that attempt to overcome some of the missing functionality or shortcomings from the 3dVista Virtual Tour Pro feature set. The methods used by these components are only confirmed to work with the latest release of 3dVista Virtual Tour Pro available at the time the license is granted. Since 3dVista Virtual Tour Pro is an evolving product, the Software is not guaranteed to be compatible with future versions of 3dVista Virtual Tour Pro. These components may only be used with a licensed copy of 3DVista Virtual Tour Pro and the 3DVista Virtual Tour Pro Player.

Although the Software works with the 3DVista Virtual Tour Pro Player, it is an entirely separate entity. Licensors has no legal affiliation with 3DVista. As such, this Agreement has no effect whatsoever on any licensing terms between You and 3DVista. In addition, all technical support related to the Software must be directed to Licensors and not 3DVista.

DEFINITIONS

"Agreement" means this License Agreement, and any amendments to it.

"You" means the individual or single entity that has agreed to be bound by the terms of this Agreement. If the Licensee is a single entity, an aggregate total of 1 employee, contractor, or assignee is permitted to use the Software. Once the license is assigned to an individual, it may not be re-assigned without Licensors's prior written approval.

"Licensee" means the individual or single entity that has agreed to be bound by the terms of this Agreement and has successfully completed payment of the agreed licensing fee.

"Licensors" means Jeff Bruce, author of the Software.

"Software" means the Library, documentation, supporting files, and samples licensed to You by Licensors under the terms of this Agreement, including any Updates thereto.

"Library" means the collection of JavaScript code provided to implement documented functionality.

"Update" means a revision or patch to the Software that may contain fixes, new features or enhancements.

"Developed Work" means the website or software application created by Licensee using the Library.

"3DVista" means 3DVista España S.L., Avenida Fernando de los ríos 58, Granada, SPAIN.

LICENSE GRANT

Upon completed payment of the agreed licensing fee, Licensors grants You this limited, non-exclusive, non-transferable, non-assignable right to use the Library to create a limited number of Developed Works for commercial usage, provided You adhere to all the terms and conditions of this Agreement. The specific limited number of Developed Works shall be established by the invoice for the licensing fee. If the invoice does not indicate the specific limited number of Developed Works, then the right to use the Library to create Developed Works shall be limited to a single Developed Work.

If you have purchased a license, You may use the Library to create Developed Works, either for your own use or for distribution to a third party, and You may license those Developed Works to end users and to third parties, who may also further license such Developed Works to end users. You may not permit any recipient of the Developed Work to extract the Library and use it separately from the Developed Work. Only a Licensee may use the Library to create Developed Works.

If you have not purchased a license, You may use the Software solely for the purposes of evaluating the performance of the Software on your system, provided You adhere to all the terms and conditions of this Agreement. You are expected to use the Software to thoroughly evaluate its usefulness and functionality before purchasing a commercial license. This "try before you buy" approach is the ultimate guarantee that the Software will perform to your satisfaction.

The foregoing is an express limited use license and not an assignment, sale, or other transfer of Software or any Intellectual Property Rights of Licensor. You may make copies of the Software in machine-readable form solely for backup purposes. You must reproduce on any such copies all copyright notices and any other proprietary legends which appear on and in the original copy of the Software.

RESTRICTIONS

You agree that you will not attempt to reverse engineer, decompile, modify, translate, or disassemble the Software in whole or in part. Without Licensor's prior written approval, You may not:

- (a) Sell, rent, lease, lend, sublicense, or in any way distribute or transfer the Software or any rights in this Agreement to third parties except as explicitly permitted by this Agreement. You may assign this Agreement to one successor to your business, whether by merger, change of control, or asset sale as long as You notify Licensor of such assignment within 30 days of its occurrence.
- (b) Share, make public, or in any way distribute or transfer to third parties the Software documentation, supporting files, or samples, in whole or in part.
- (c) Include the Software as part of any product or service that would compete to any degree with the Software. Such competitive products and services are defined as software libraries, developer toolkits, or services that provide similar functionality as the Software and that are intended for software developers, product creators, and/or system integrators.
- (d) Alter or remove any comments or copyright notices included with the Software.

TERMINATION

Licensor reserves the right to terminate your right to use the Software, including the Library, if in Licensor's opinion You fail to comply with any of the terms of this Agreement. In addition, You shall have no right to a refund of any payments made to Licensor.

COPYRIGHT

The Software and all rights, without limitation including proprietary rights therein, are owned by Licensor or its suppliers and are protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Software is licensed, not sold. You acknowledge that no title to the intellectual property in the Software is transferred to You. You further acknowledge that title and full ownership rights to the Software will remain the exclusive property of Licensor and You will not acquire any rights to the Software except as expressly set forth in this Agreement.

GOVERNING LAW AND JURISDICTION

The parties agree to submit to the Ohio Courts only, for any dispute arising out of this Agreement and consent to the jurisdiction of said Courts and further agree that any and all matters of dispute shall be adjudicated, governed and controlled under and by Ohio law and this paragraph shall supersede any conflicting choice of law rules. The parties expressly stipulate that the 1980 Convention on Contracts for the International Sale of Goods shall not apply, nor shall the Uniform Computer Information Transactions Act.

SEVERABILITY

If any part of this Agreement is found void and unenforceable, it will not affect the validity of the balance of this Agreement, which shall remain valid and enforceable according to its terms. In the event that You fail to comply with this Agreement, the license is terminated and You agree to cease using the Software and uninstall the Software from your computer.

ENTIRE AGREEMENT

This Agreement represents the entire agreement of the parties hereto related to the subject matter hereof and any prior agreements, promises, negotiations, or representations, whether oral or written, not expressly set forth in this Agreement are of no force and effect.
